LOGOS UNIVERSITY INT. and OLYMPOS Universal Intellectual Centre

agree to cooperate in academic exchanges, program development and research. This document establishes the guiding terms and principles of collaboration between the two institutions.

I. Legal frameworks of both universities

LUI is a nonprofit maintenance organization, located in Miami, FL - USA.

LUI is a higher education recognized by the Florida Department of State Division of Corporations and Florida Department Education (<http://dos.myflorida.com/>)

OLYMPOS Universal Intellectual Centre is a nonprofit world center and a cradle of knowledge for science and art. It is located in Athens, Greece and is approved under the Decision Nr. 4303/1984 of the Athens First Instance Court of Justice with Reg. Nr. 13282, thus recognized and functioning under the laws of the Hellenic Republic and consequently the European Union.

II. Purpose of the Agreement

Given the interest of both schools to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions of higher education, this agreement seeks to create a multi-disciplinary, multi-level relationship between LUI – LOGOS UNIVERSITY INT. and OLYMPOS Universal Intellectual Centre. It does not purport to prescribe areas of collaboration, but rather to provide a framework to facilitate the exploration of specific actions that may be taken for the mutual benefit of the two schools. Potential areas include, but are not limited to:

1. Exchange teaching and research personnel
2. Cooperative development of courses and academic programs





3. Development of joint scientific and/or technological research projects
4. Collaboration in the area of academic publications
5. Other activities of mutual interest regarding academic or scientific and technological research matters

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both universities will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of a year. After this first year it will be automatically extended for an indefinite period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least (3) three months before the expiry date.

Any additions, changes, or deletions to this document must be approved by these representatives of both universities. All notices shall be in writing and shall be directed to these individuals as follows:
